The birth of portfolio.ESG in 2023 enshrines the simplification of the work of analyzing ESG products, while maintaining the utmost integrity, being based on an immense database of EETs. For the first time, it is possible with a single click to find out how sustainable a portfolio of funds and ETFs is, thus also meeting the requirements of MiFID II. Thanks to it, it is possible to identify how well the portfolio: 1) consists of sustainable investments, as defined by the Sfdr, (thus not just aligned with E or S); 2) is specifically environmentally (E) and socially (S) sustainable; 3) is aligned with the EU Taxonomy; 4) is art. 8 and art. 9 according to the Sfdr; 5) measures PAI indicators; 6) is aligned with the Sustainable Development Goals (SDGs); 7) engages with invested companies; 8) implements sector (arms, tobacco, etc.), regulatory, and country exclusions; 9) implements ESG thematic investments; 10) does ESG integration.

Born in 2016, **ESG.Identity Corporate Index** (ex IGI) is the first **index** aimed at quantifying the level of integration of ESG factors in the **governance structure of a company**. It is built on the basis of a survey of the top 100 Italian listed companies, all the companies that publish the DNF and the major unlisted companies. It is developed with scientific partners. It is a quantitative index constructed on the basis of a questionnaire addressed to companies, and it is useful for the purpose of an **internal evaluation** and sector **benchmark**.

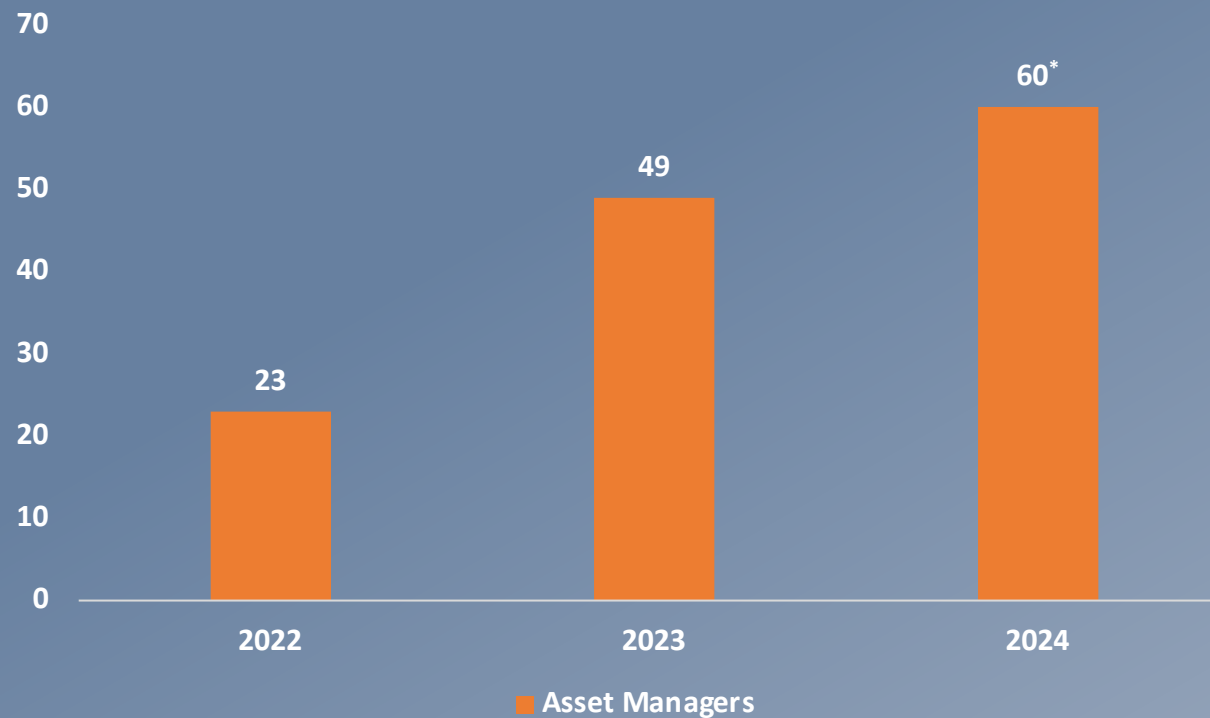

Born in 2022, **ESG.IAMA** is the first quantitative **index** that set out to measure the Asset Managers' **ESG Identity**, which includes the set of distinctive elements of an entity, starting from its organizational structure (governance) to the ESG consistency and coherence of its products to the market, going through the ways in which the entity thinks (its ESG corporate culture) and engages on the sustainable front (its ESG purpose). For the Asset Managers, it is useful for the purpose of an **internal evaluation** and sector **benchmark**, while for the **Pension Funds** is useful to evaluate the Asset Managers' sustainability as a criterion for their tenders.

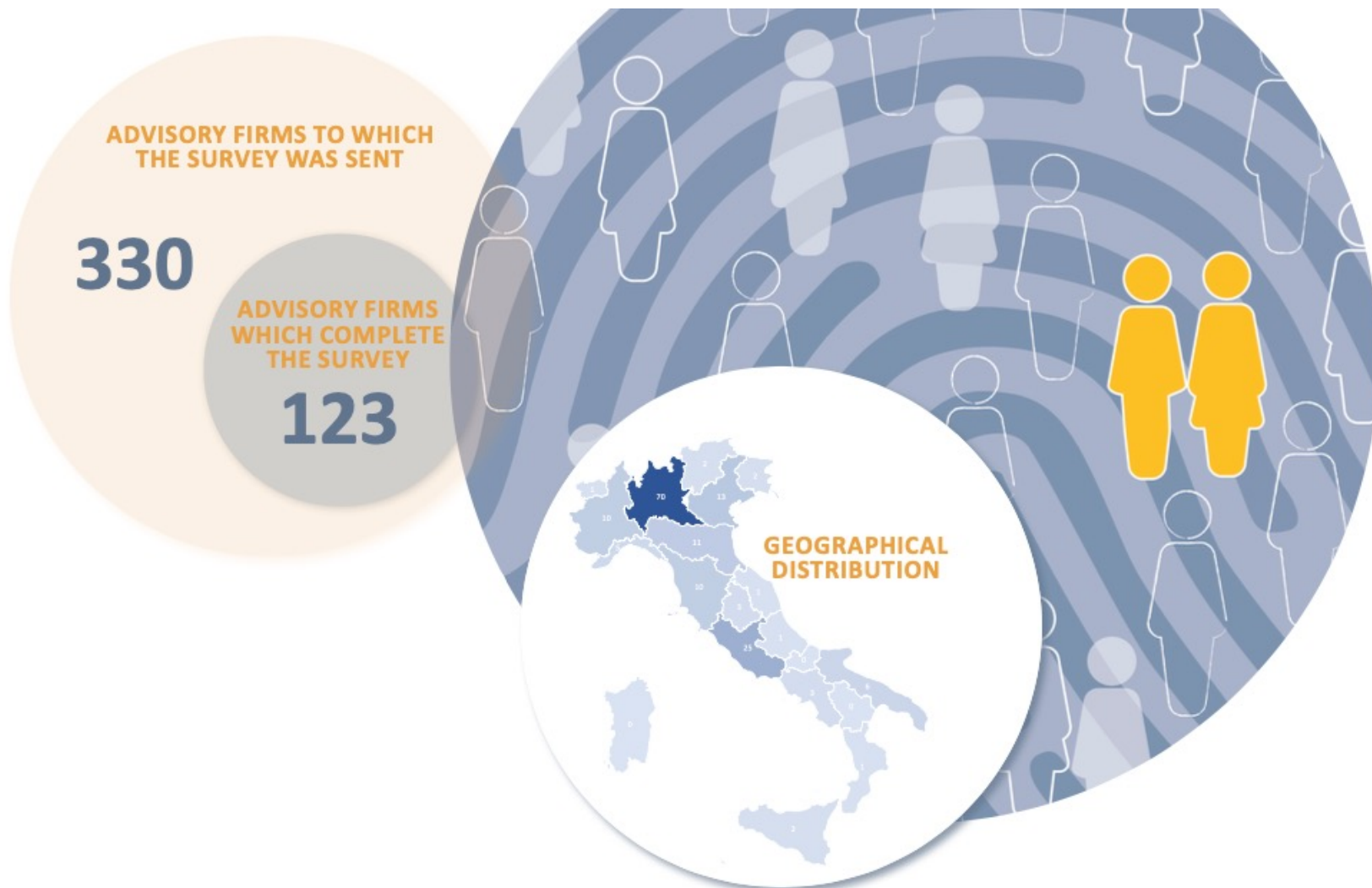

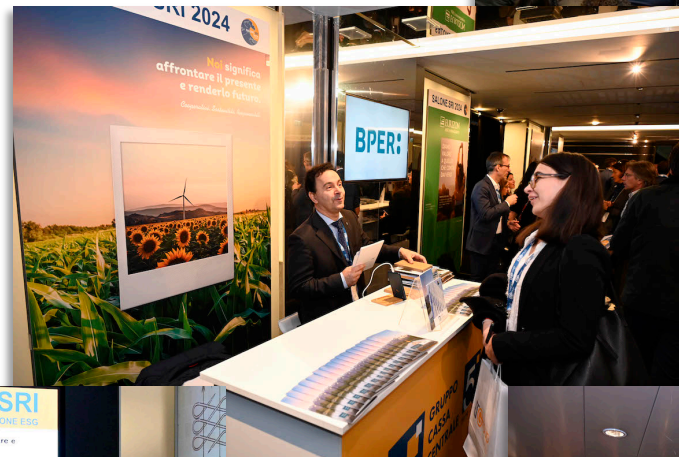

Until 2022, the awards were called SRI Awards, went to investigate the sustainability of financial products, and were given to:
